## HOW TO CITE RULES AND RSMo

**RULES**—Cite material in the *Missouri Register* by volume and page number, for example, Vol. 28, *Missouri Register*, page 27. The approved short form of citation is 28 MoReg 27.

The rules are codified in the *Code of State Regulations* in this system—

They are properly cited by using the full citation, i.e., 1 CSR 10-1.010.

Each department of state government is assigned a title. Each agency or division within the department is assigned a division number. The agency then groups its rules into general subject matter areas called chapters and specific areas called rules. Within a rule, the first breakdown is called a section and is designated as (1). Subsection is (A) with further breakdown into paragraph 1., subparagraph A., part (I), subpart (a), item I. and subitem a.

**RSMo**—The most recent version of the statute containing the section number and the date.

**R**ules appearing under this heading are filed under the authority granted by section 536.025, RSMo 2000. An emergency rule may be adopted by an agency if the agency finds that an immediate danger to the public health, safety, or welfare, or a compelling governmental interest requires emergency action; follows procedures best calculated to assure fairness to all interested persons and parties under the circumstances; follows procedures which comply with the protections extended by the *Missouri* and the *United States Constitutions*; limits the scope of such rule to the circumstances creating an emergency and requiring emergency procedure, and at the time of or prior to the adoption of such rule files with the secretary of state the text of the rule together with the specific facts, reasons, and findings which support its conclusion that there is an immediate danger to the public health, safety, or welfare which can be met only through the adoption of such rule and its reasons for concluding that the procedure employed is fair to all interested persons and parties under the circumstances.

**R**ules filed as emergency rules may be effective not less than ten (10) days after filing or at such later date as may be specified in the rule and may be terminated at any time by the state agency by filing an order with the secretary of state fixing the date of such termination, which order shall be published by the secretary of state in the *Missouri Register* as soon as practicable.

**A**ll emergency rules must state the period during which they are in effect, and in no case can they be in effect more than one hundred eighty (180) calendar days or thirty (30) legislative days, whichever period is longer. Emergency rules are not renewable, although an agency may at any time adopt an identical rule under the normal rulemaking procedures.

## Title 2—DEPARTMENT OF AGRICULTURE Division 70—Plant Industries Chapter 11—Missouri Plant Law Quarantines

### EMERGENCY RULE

#### 2 CSR 70-11.070 Pine Shoot Beetle Intrastate Quarantine

*PURPOSE: This rule establishes a quarantine against the spread of a serious insect pest, known as the pine shoot beetle, **Tomicus piniperda** Linnaeus, to other uninfested areas of the state of Missouri, and other states, and establishes those articles and areas which are to be regulated.*

*EMERGENCY STATEMENT: The Missouri Department of Agriculture, Plant Industries Division, after consultation with United States Department of Agriculture officials, believes this emergency rule is fair to all interested persons and parties under the circumstances. If this emergency rule is not enacted, the United States Department of Agriculture will quarantine the entire state of Missouri for pine shoot beetle regulated articles, unnecessarily impeding a two hundred fifty (250) million+ dollar per year nursery and landscape industry and a \$7.3 billion dollar per year forest products industry. Missouri has approximately two hundred twenty-five thousand (225,000) acres of forest pine, containing nearly four (4) billion board feet (International), which is valued at over \$482 million. The pine shoot beetle, **Tomicus piniperda** Linnaeus, native to Europe, was discovered in Ohio in 1992 and has since been found to be estab-*

*lished in nineteen (19) total U.S. states. It was first confirmed in Missouri in Macon County in April 2012, with subsequent confirmations in Lewis County in June 2012 and Marion County in July 2012. The beetle attacks new shoots of pine trees, stunting the growth of the trees. The pine shoot beetle may also attack stressed pine trees by breeding under the bark at the base of the trees. The beetles can cause severe decline in the health of the trees, and in some cases, kill the trees when high populations exist. In states regulated under the current United States Department of Agriculture quarantine, the beetle has been found in pine tree production areas, Christmas tree farms, nurseries, mature pine stands, and areas surrounding mill yards that process pine logs. Pine trees make up a significant percentage of landscape trees and Christmas tree farm production. The scope of this emergency rule is limited to the circumstances creating the emergency and complies with the protections extended in the *Missouri* and *United States Constitutions*. This emergency rule was filed October 2, 2012, becomes effective October 12, 2012, and expires April 9, 2013.*

(1) It has been determined that the pine shoot beetle, native to Europe, and a destructive pest of pine (*Pinus* spp.) has become established in Missouri. It is not yet known to be generally distributed throughout the state of Missouri, and its introduction into the remainder of the state would cause further economic and ecological loss. As such, the state entomologist, under the authority of section 263.140, RSMo, of the Missouri Plant Law does now establish a quarantine to prevent the spread of this pest into uninfested parts of Missouri and other states and now sets forth the name of this pest against which the quarantine is established, the quarantined area, the articles regulated, the rules governing movement of regulated articles, and the penalty.

(2) The following definitions shall apply to this quarantine:

(A) Bark means the natural bark of a tree, including the ingrown bark around the knots and bark pockets between rings of annual growth and an additional one-half- (½-) inch of wood, including the vascular cambium;

(B) Certificate of inspection is a document authorized to be issued by the director to allow the movement of regulated articles from the quarantined area to destinations within the state of Missouri;

(C) Compliance agreement is a written agreement between the director and a person or entity moving regulated articles out of the quarantined area;

(D) Director is the director of the Missouri Department of Agriculture or his/her authorized representative;

(E) Established refers to the presence of a reproducing population of the pine shoot beetle;

(F) Inspector refers to an employee of the Missouri Department of Agriculture, Plant Pest Control Bureau or United States Department of Agriculture/Animal and Plant Health Inspection Service/Plant Protection and Quarantine (USDA/APHIS/PPQ) authorized to enforce the provisions of this quarantine;

(G) Limited permit means a document which an inspector, or person operating under a compliance agreement, affirms that the regulated article identified on the document is eligible for intrastate and/or interstate movement in accordance with this quarantine to a specified destination and only in accordance with specified conditions; and

(H) Pine shoot beetle is the insect classified as *Tomicus piniperda* Linnaeus in any life stage.

(3) The following is a list of articles, the movement of which is regulated:

(A) The pine shoot beetle, *Tomicus piniperda* Linnaeus, in any living stage of development;

(B) Nursery stock, Christmas trees, bark products, raw pine materials for pine wreaths and garlands, lumber with bark attached, and other material living, dead, cut, or fallen, including logs, stumps, roots, branches, and composted and uncomposted chips of the genus *Pinus*;

(C) Any item made from or containing pine wood that is capable of spreading the pine shoot beetle; and

(D) Any article, product, or means of conveyance when it is determined by the director to present the risk of spread of the pine shoot beetle.

(4) The director may designate any area of Missouri as quarantined for the pine shoot beetle by listing the designated area on the Missouri Department of Agriculture website ([www.mda.mo.gov](http://www.mda.mo.gov)). The director will notify affected counties upon designation.

(5) The following are conditions of movement of regulated articles:

(A) Movement Within a Quarantined Area—Movement of the regulated article within a quarantined area is allowed;

(B) Movement Out of a Quarantined Area—Movement of the regulated article from any quarantined area to any destination outside the quarantined area is prohibited, except under the following conditions:

1. Pine Christmas trees and brush—Movement of Christmas trees and brush during October, November, and December, or when ambient air temperature is below ten degrees Celsius (10 °C) (fifty degrees Fahrenheit (50 °F)), is allowed under a limited permit, certificate, or compliance agreement if—

A. Visual inspection of the trees or brush in a shipment or the plantation does not detect the presence of the pine shoot beetle. The number of trees selected for inspection is determined by the size and type of shipment, in accordance with 7 CFR, Ch. III, Part 301.50;

B. The Christmas tree plantation is under and adhering to the conditions of a compliance agreement; or

C. The shipment of Christmas trees or brush is treated using one (1) of the fumigation methods as outlined in accordance with 7 CFR, Ch. III, Part 301.50; or

2. Pine logs and lumber with bark attached—Movement of pine logs or lumber with bark attached out of the quarantine area is prohibited, except under the following conditions:

A. If the shipment is taking place from July 1 through October 31, and the source of the pine was felled during the same period, the shipment may move unrestricted; or

B. If the shipment is taking place from November 1 through June 30 movement is allowed under the following conditions:

(I) The shipment has been treated at the point of origin under the supervision of an inspector with the approved method of fumigation as outlined in accordance with 7 CFR, Ch. III, Part 301 and issued a certificate attesting to such; or

(II) The shipment will be moved under a limited permit to a receiving facility that is operating under, and meeting the standards set forth in, a compliance agreement approved by the director. The compliance agreement will specify the conditions for handling, processing, and/or utilizing pine bark to prevent the spread of the pine shoot beetle; or

3. Pine bark and pine mulch—Movement of pine bark and pine mulch out of the quarantine area is prohibited, except under the following conditions:

A. If the shipment is taking place from July 1 through October 31, and the source of the pine was felled during the same period, then the shipment may move unrestricted after the issuance of a certificate by an inspector attesting to such; or

B. If the shipment is taking place from November 1 through June 30, movement is allowed under the following conditions:

(I) The shipment has been treated at the point of origin under the supervision of an inspector with the approved method of fumigation as outlined in accordance with 7 CFR, Ch. III, Part 301.50 and issued a certificate attesting to such; or

(II) The pine bark or pine mulch shipment will be meeting the standards set forth in a compliance agreement approved by the director. The compliance agreement will specify the conditions for the handling and processing of the pine bark which will prevent the spread of the pine shoot beetle; or

4. Pine nursery stock—Movement of pine nursery stock is allowed under a certificate or compliance agreement if—

A. A visual inspection of one hundred percent (100%) of the trees in a shipment is conducted. Evidence of infestation in any one (1) tree will result in the rejection of that tree; or

B. The pine tree nursery is under, and adhering to the conditions of, a compliance agreement; and

(C) Transiting Quarantined Areas—Movement of the regulated article from an area outside the quarantined area to any destination outside the quarantined area that transits through the quarantined area is allowed under the following conditions:

1. The point of origin must be indicated on the waybill, invoice, or shipping document that accompanies the shipment; and

2. The shipment must move through the quarantined areas without stopping except to drop-off loads, refuel, or for traffic conditions such as traffic lights or stop signs. If the regulated article is transiting a quarantined area during the period of January 1 through September 30, and the temperature is higher than ten degrees Celsius (10 °C) (fifty degrees Fahrenheit (50 °F)), the article must be shipped in an enclosed vehicle or completely covered (such as with plastic, canvas, or other closely woven cloth) so as to prevent access by the pine shoot beetle.

(6) Regulated articles transported in violation of this quarantine must be treated, destroyed, or returned to the point of origin at the discretion of the state entomologist. Common carriers or other carriers, persons, firms, or corporations who transport or move regulated articles in violation of this quarantine and these rules will be subject to the penalties named in section 263.180, RSMo, of the Missouri Plant Law.

(7) These rules are distinct from, and in addition to, any federal statute, regulation, or quarantine order addressing the interstate movement of articles from the quarantined area or the state of Missouri.

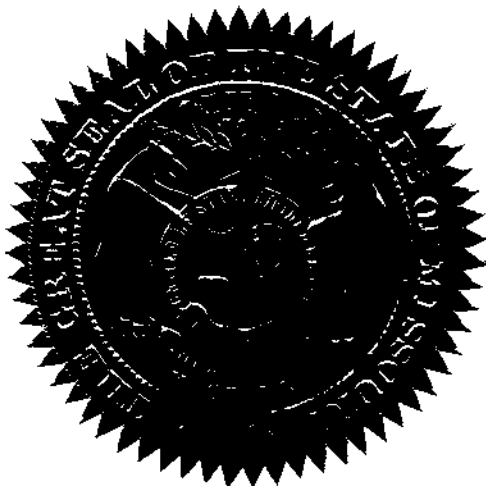



**U**nder this heading will appear the text of proposed rules and changes. The notice of proposed rulemaking is required to contain an explanation of any new rule or any change in an existing rule and the reasons therefor. This is set out in the Purpose section with each rule. Also required is a citation to the legal authority to make rules. This appears following the text of the rule, after the word "Authority."

**E**ntirely new rules are printed without any special symbolology under the heading of the proposed rule. If an existing rule is to be amended or rescinded, it will have a heading of proposed amendment or proposed rescission. Rules which are proposed to be amended will have new matter printed in boldface type and matter to be deleted placed in brackets.

**A**n important function of the *Missouri Register* is to solicit and encourage public participation in the rulemaking process. The law provides that for every proposed rule, amendment, or rescission there must be a notice that anyone may comment on the proposed action. This comment may take different forms.

**I**f an agency is required by statute to hold a public hearing before making any new rules, then a Notice of Public Hearing will appear following the text of the rule. Hearing dates must be at least thirty (30) days after publication of the notice in the *Missouri Register*. If no hearing is planned or required, the agency must give a Notice to Submit Comments. This allows anyone to file statements in support of or in opposition to the proposed action with the agency within a specified time, no less than thirty (30) days after publication of the notice in the *Missouri Register*.

**A**n agency may hold a public hearing on a rule even though not required by law to hold one. If an agency allows comments to be received following the hearing date, the close of comments date will be used as the beginning day in the ninety (90)-day-count necessary for the filing of the order of rulemaking.

**I**f an agency decides to hold a public hearing after planning not to, it must withdraw the earlier notice and file a new notice of proposed rulemaking and schedule a hearing for a date not less than thirty (30) days from the date of publication of the new notice.

**PROPOSED RULE**

**2 CSR 70-11.070 Pine Shoot Beetle Intrastate Quarantine**

*PURPOSE: This rule establishes a quarantine against the spread of a serious insect pest, known as the pine shoot beetle, **Tomicus piniperda** Linnaeus, to other uninfested areas of the state of Missouri, and other states, and establishes those articles and areas which are to be regulated.*

(1) It has been determined that the pine shoot beetle, native to Europe, and a destructive pest of pine (*Pinus* spp.) has become established in Missouri. It is not yet known to be generally distributed throughout the state of Missouri, and its introduction into the remain-

der of the state would cause further economic and ecological loss. As such, the state entomologist, under the authority of section 263.140, RSMo, of the Missouri Plant Law does now establish a quarantine to prevent the spread of this pest into uninfested parts of Missouri and other states and now sets forth the name of this pest against which the quarantine is established, the quarantined area, the articles regulated, the rules governing movement of regulated articles, and the penalty.

(2) The following definitions shall apply to this quarantine:

(A) Bark means the natural bark of a tree, including the ingrown bark around the knots and bark pockets between rings of annual growth and an additional one-half- (1/2-) inch of wood, including the vascular cambium;

(B) Certificate of inspection is a document authorized to be issued by the director to allow the movement of regulated articles from the quarantined area to destinations within the state of Missouri;

(C) Compliance agreement is a written agreement between the director and a person or entity moving regulated articles out of the quarantined area;

(D) Director is the director of the Missouri Department of Agriculture or his/her authorized representative;

(E) Established refers to the presence of a reproducing population of the pine shoot beetle;

(F) Inspector refers to an employee of the Missouri Department of Agriculture, Plant Pest Control Bureau or United States Department of Agriculture/Animal and Plant Health Inspection Service/Plant Protection and Quarantine (USDA/APHIS/PPQ) authorized to enforce the provisions of this quarantine;

(G) Limited permit means a document which an inspector, or person operating under a compliance agreement, affirms that the regulated article identified on the document is eligible for intrastate and/or interstate movement in accordance with this quarantine to a specified destination and only in accordance with specified conditions; and

(H) Pine shoot beetle is the insect classified as *Tomicus piniperda* Linnaeus in any life stage.

(3) The following is a list of articles, the movement of which is regulated:

(A) The pine shoot beetle, *Tomicus piniperda* Linnaeus, in any living stage of development;

(B) Nursery stock, Christmas trees, bark products, raw pine materials for pine wreaths and garlands, lumber with bark attached, and other material living, dead, cut, or fallen, including logs, stumps, roots, branches, and composted and uncomposted chips of the genus *Pinus*;

(C) Any item made from or containing pine wood that is capable of spreading the pine shoot beetle; and

(D) Any article, product, or means of conveyance when it is determined by the director to present the risk of spread of the pine shoot beetle.

(4) The director may designate any area of Missouri as quarantined for the pine shoot beetle by listing the designated area on the Missouri Department of Agriculture website ([www.mda.mo.gov](http://www.mda.mo.gov)). The director will notify affected counties upon designation.

(5) The following are conditions of movement of regulated articles:

(A) Movement Within a Quarantined Area—Movement of the regulated article within a quarantined area is allowed;

(B) Movement Out of a Quarantined Area—Movement of the regulated article from any quarantined area to any destination outside the quarantined area is prohibited, except under the following conditions:

1. Pine Christmas trees and brush—Movement of Christmas



trees and brush during October, November, and December, or when ambient air temperature is below ten degrees Celsius (10 °C) (fifty degrees Fahrenheit (50 °F)), is allowed under a limited permit, certificate, or compliance agreement if—

A. Visual inspection of the trees or brush in a shipment or the plantation does not detect the presence of the pine shoot beetle. The number of trees selected for inspection is determined by the size and type of shipment, in accordance with 7 CFR, Ch. III, Part 301.50;

B. The Christmas tree plantation is under and adhering to the conditions of a compliance agreement; or

C. The shipment of Christmas trees or brush is treated using one (1) of the fumigation methods as outlined in accordance with 7 CFR, Ch. III, Part 301.50; or

2. Pine logs and lumber with bark attached—Movement of pine logs or lumber with bark attached out of the quarantine area is prohibited, except under the following conditions:

A. If the shipment is taking place from July 1 through October 31, and the source of the pine was felled during the same period, the shipment may move unrestricted; or

B. If the shipment is taking place from November 1 through June 30 movement is allowed under the following conditions:

(I) The shipment has been treated at the point of origin under the supervision of an inspector with the approved method of fumigation as outlined in accordance with 7 CFR, Ch. III, Part 301 and issued a certificate attesting to such; or

(II) The shipment will be moved under a limited permit to a receiving facility that is operating under, and meeting the standards set forth in, a compliance agreement approved by the director. The compliance agreement will specify the conditions for handling, processing, and/or utilizing pine bark to prevent the spread of the pine shoot beetle; or

3. Pine bark and pine mulch—Movement of pine bark and pine mulch out of the quarantine area is prohibited, except under the following conditions:

A. If the shipment is taking place from July 1 through October 31, and the source of the pine was felled during the same period, then the shipment may move unrestricted after the issuance of a certificate by an inspector attesting to such; or

B. If the shipment is taking place from November 1 through June 30, movement is allowed under the following conditions:

(I) The shipment has been treated at the point of origin under the supervision of an inspector with the approved method of fumigation as outlined in accordance with 7 CFR, Ch. III, Part 301.50 and issued a certificate attesting to such; or

(II) The pine bark or pine mulch shipment will be meeting the standards set forth in a compliance agreement approved by the director. The compliance agreement will specify the conditions for the handling and processing of the pine bark which will prevent the spread of the pine shoot beetle; or

4. Pine nursery stock—Movement of pine nursery stock is allowed under a certificate or compliance agreement if—

A. A visual inspection of one hundred percent (100%) of the trees in a shipment is conducted. Evidence of infestation in any one (1) tree will result in the rejection of that tree; or

B. The pine tree nursery is under, and adhering to the conditions of, a compliance agreement; and

(C) Transiting Quarantined Areas—Movement of the regulated article from an area outside the quarantined area to any destination outside the quarantined area that transits through the quarantined area is allowed under the following conditions:

1. The point of origin must be indicated on the waybill, invoice, or shipping document that accompanies the shipment; and

2. The shipment must move through the quarantined areas without stopping except to drop-off loads, refuel, or for traffic conditions such as traffic lights or stop signs. If the regulated article is transiting a quarantined area during the period of January 1 through September 30, and the temperature is higher than ten degrees Celsius (10 °C) (fifty degrees Fahrenheit (50 °F)), the article must be

shipped in an enclosed vehicle or completely covered (such as with plastic, canvas, or other closely woven cloth) so as to prevent access by the pine shoot beetle.

(6) Regulated articles transported in violation of this quarantine must be treated, destroyed, or returned to the point of origin at the discretion of the state entomologist. Common carriers or other carriers, persons, firms, or corporations who transport or move regulated articles in violation of this quarantine and these rules will be subject to the penalties named in section 263.180, RSMo, of the Missouri Plant Law.

(7) These rules are distinct from, and in addition to, any federal statute, regulation, or quarantine order addressing the interstate movement of articles from the quarantined area or the state of Missouri.

**PURPOSE:** This rule provides a description of the organization and general methods and scope of operation of the Missouri Air Conservation Commission and the Air Pollution Control Program of the Missouri Department of Natural Resources and provides for public information and participation. This amendment will update the public information section to reflect current notification procedures for public hearings and rules in development. In addition, the Air Pollution Control Program section titles and main functions will be updated to incorporate changes made since the last rule amendment in 1998. The evidence supporting the need for this proposed rulemaking, per 536.016, RSMo, is the public hearing testimony for this rulemaking.

[(A)]1. Air Conservation Commission. The seven (7) member commission is the state's governing body for the control, abatement, and prevention of air pollution ([sections] 643.030 and 643.040,

RSMo) having authority ([section] 643.050, 643.055, 643.225, and 643.305, RSMo) to—

[1.]A. Adopt, promulgate, amend, and rescind rules;

[2.]B. Establish air quality control regions;

[3.]C. Require submission of relevant information;

[4.]D. Conduct and hold hearings upon appeals from orders, permit denials, and other actions of the director, settle compliance disputes at public hearings before the commission, or refer alleged violations to the county prosecutor or attorney general;

[5.]E. Develop facts, make investigations, and make orders and determinations;

[6.]F. Prepare and develop a comprehensive plan for the prevention, abatement, and control of air pollution, including emergency alert procedures;

[7.]G. Grant authority to political subdivisions to control air pollution;

[8.]H. Grant, modify, and revoke exceptions and variances to rules; and

[9.]I. Suspend the order of rulemaking when necessary for public health, safety, and welfare prior to filing the final order of rulemaking.

[(B)]2. Director. The director of the Department of Natural Resources, serving at the pleasure of the governor, or the director's authorized representative, has the responsibility and the authority ([section] 643.060, RSMo) to—

[1.]A. Employ staff and consultants as necessary to carry out the Missouri Air Conservation Law;

[2.]B. Accept, receive, and administer grants, gifts, or other funds from public and private agencies;

[3.]C. Receive, budget, and expend appropriated moneys;

[4.]D. Arrange, notify, attend, and record all meetings of the Missouri Air Conservation Commission (MACC);

[5.]E. Investigate complaints, issue abatement orders, recommend that the MACC request legal action be taken by the attorney general under [section] 643.090.2, RSMo, recommend legal action be taken by the attorney general under [section] 643.090.2, RSMo, and enforce provisions of the Missouri Air Conservation Law;

[6.]F. Receive and act upon reports, plans, specifications, and permit applications submitted under rules promulgated by MACC;

[7.]G. Receive and investigate petitions for variances and submit recommendations to MACC;

[8.]H. Carry out the directions of MACC between meetings including conducting inspections and investigations, obtaining and assembling data, and preparing reports;

[9.]I. Submit revisions of the State Implementation Plan (SIP) to the United States Environmental Protection Agency (EPA) for approval; and

[10.]J. Enact air pollution emergency alert procedures.

[(C)]3. Staff [D]director. The staff director of the Air Pollution Control Program of the Department of Natural Resources serves at the pleasure of the commission and handles the day-to-day matters, including all responsibilities delegated to the director's authorized representative.

[(D)]4. Air Pollution Control Program. The program is divided into five (5) sections with the [following] main task descriptions [of each:] listed below—

1. The administration section assists the Air Pollution Control Program sections by providing personnel services, budgeting, procurement, data processing, record keeping, computer services and public information;

2. The enforcement section—

A. Performs or oversees source compliance testing;

B. Technically reviews variance applications and recommend action to be taken;

C. Prepares abatement orders and consent orders;

D. Determines and tracks compliance of air pollution

*sources;*

*E. Coordinates with the regional office program and the local air pollution control agencies in matters of compliance determination, permitting and litigation;*

*F. Resolves violations through out-of-court settlements with the assistance of the attorney general's office;*

*G. Provides continuing technical support to legal counsel for those cases after litigation has been authorized by MACC;*

*H. Issues sales tax exemptions on air pollution control equipment;*

*I. Assists in the audits of the local agencies; and*

*J. Presents routine activity and complaint reports to MACC;*

*3. The technical support section—*

*A. Collects the emission inventory and maintains the emission database;*

*B. Maintains facility or site information;*

*C. Obtains air quality data, updates EPA AIRS (Air Information Retrieval System) database and disseminates data;*

*D. Coordinates with the laboratory services program for the establishment and maintenance of air monitoring sites;*

*E. Maintains meteorological data;*

*F. Reviews permit applicant's air quality modeling and air quality analysis;*

*G. Provides modeling and air quality analysis for other sections in the program;*

*H. Conducts and coordinates Ambient Air Monitoring Network Reviews;*

*I. Coordinates Maximum Achievable Control Technology (MACT) workgroup activities and provides information in order to implement MACT;*

*J. Maintains the air monitoring SIP;*

*K. Coordinates air quality data input from local air pollution control agencies and the laboratory services program;*

*L. Receives, evaluates and makes recommendations to the director whether to certify as exempt sales tax exemption requests for pollution control or monitoring equipment; and*

*M. Provides technical support to legal counsel for those permits issued and appealed by an applicant or citizen;*

*4. The planning section—*

*A. Develops proposals for new rules and for amending or rescinding in-place rules of MACC for presentation to MACC;*

*B. Meets all public participation requirements of state and federal laws involving rulemaking and SIP revisions;*

*C. Provides SIP coordination and maintenance and prepares SIP revisions for the director's action;*

*D. Provides highway project assessment of mobile source emissions as requested by other governmental agencies;*

*E. Provides a motor vehicle inspection/maintenance program as may be required;*

*F. Provides liaison with the secretary of state, EPA, other regulatory bodies and private industry regarding MACC rules governing air pollution control;*

*G. Prepares the air quality annual report;*

*H. Prepares all reports as required in the SIP;*

*I. Revises permitting regulations consistent with Title V CFR 40 Part 70 revisions;*

A notice of proposed rulemaking containing the text of the proposed amendment was published in the *Missouri Register* on July 2, 2012 (37 MoReg 1007-1008). Those sections with changes are reprinted here. This proposed amendment becomes effective thirty (30) days after publication in the *Code of State Regulations*.

**SUMMARY OF COMMENTS:** The public comment period ended August 1, 2012, and the commission held a public hearing on the proposed amendment on August 2, 2012. The commission received timely written comments from the staff of the Missouri Public Service Commission and from Southwestern Bell Telephone Company, d/b/a AT&T Missouri. In addition, the commission's staff and the Office of the Public Counsel offered comments at the hearing.

**COMMENT #1:** The commission's staff explained that the chief purpose of the amendment is to make permanent a federally mandated change in Missouri's income-based eligibility criterion for the

Lifeline program to match federal eligibility standards. That change has been temporarily implemented through an emergency rulemaking that is effective June 1, 2012, through February 28, 2013. (The emergency rule was published in the *Missouri Register* on July 2, 2012 (37 MoReg 1003-1004)).

**RESPONSE:** The commission thanks its staff for its comment. The commission has made no changes to the rule because of this comment.

**COMMENT #2:** AT&T Missouri offered a written comment indicating its general support for the proposed amendment. However, AT&T Missouri proposes a slight modification to the new definition of "low-income customer" in section (11) of the rule. AT&T proposes to insert the word "household" before "income" in the definition to make it clear that it is household income, not individual income, that determines eligibility to participate in the program. Staff agrees the change is needed to make the definition consistent with federal law and supports the proposed change.

**RESPONSE AND EXPLANATION OF CHANGE:** The commission will insert "household" before "income" in the definition of low-income customer found in section (11).

**COMMENT #3:** Public counsel expressed concern at the hearing about the proposed deletion of the substance of the definition of "essential local telecommunications services" in section (6). The commission proposes to delete that definition and replace it with a reference to the definition of "voice telephony service" in a new section (17). Staff explained that the new definition of "voice telephony service" would make the commission's rule consistent with regulations for the federal Universal Service Fund as set forth by the Federal Communications Commission (FCC). Public counsel is concerned that changing the definition of "essential local telecommunications services" in this rule may have ramifications beyond staff's intent to make the commission's rule correspond to that of the FCC. Public counsel asks the commission to study the matter more closely before revising the definition.

Staff denied the substance of public counsel's concern, but indicated it is currently drafting a broader revision of the commission's rules regarding the Missouri Universal Service Fund. Staff confirmed that the proposed revision of the definition of "essential local telecommunications services" is not related to the emergency amendment of Missouri's income-based eligibility criterion for the Lifeline program, which staff indicated was the primary purpose of this rulemaking. Therefore, staff conceded that the commission could defer making a change to the definition until it considers the upcoming overall revision of the commission's rules.

**RESPONSE AND EXPLANATION OF CHANGE:** The commission will not change the definition of essential local telecommunications service in this rulemaking. In doing so, the commission is not making any decision regarding the merits of the change proposed by staff or the position taken by public counsel. Rather, it is deferring that decision until the matter is again presented as part of the upcoming broader revision of the Missouri Universal Service Fund rules. Staff explained that if the commission chose to not amend the definition of "essential local telecommunications services" at this time, it could best do so by not deleting the existing section (6) and by deleting the proposed new section (17) definition of "voice telephony services." The commission will revise its rulemaking as staff suggests.

**COMMENT #4:** In its written comment, AT&T Missouri proposed a revision to the definition of "voice telephony services" to make it fully consistent with the federal definition.

**RESPONSE:** Since the commission decided in response to comment 3 to delete the definition of "voice telephony services" from the rule, it will not make the change proposed by AT&T Missouri.
